LCV Vehicles up to 3500kg including all car derived vans, commercial vans, pick-ups, tippers and 4x4 vehicles	<ul> <li>Vehicles supplied to the contract must be appropriate to the task, in good condition, comply with vehicle type approval and all other current transport legislation</li> <li>Pick-up and tipper bodies must be of robust construction meeting all C&amp;U regulations and appropriate body access steps, handles and working at height protection must be provided where required</li> <li>Vans - Full Steel bulkhead or minimum ¾ ply bulkhead</li> <li>Rear Hi-Visibility warning (Chapter 8) where legally required (High speed road)</li> <li>Appropriate internal lighting</li> <li>Where a towing facility is fitted it must be a 3500kg rated tow bar with a pin and eye hitch (Dixon &amp; Bate preferred), riser plate fitted where required &amp; electrical connections compliant with C&amp;U and lighting regulations</li> <li>For towing operations a rear number plate must be provided</li> <li>Where applicable on board welfare facilities should be provided - Hand wash &amp; skin care products, paper towel, first aid kit and an eye wash station</li> <li>Where gas bottle carriage is required there must be designated &amp; vented gas bottle storage</li> <li>Where fuel carriage is required it must be in appropriately labelled containers in designated secured storage areas</li> <li>Where gas or fuel is carried the provision of an appropriate fire extinguisher is mandatory</li> <li>Designated storage racking for tools and fittings must be provided wherever possible</li> <li>Full Length rear step for all 3.5T vans</li> <li>Fitted beacons, audible reverse warning (White noise)</li> <li>Livery in line with Morgan Sindall branding guidelines</li> <li>Best practice fitments and policies</li> <li>Vehicle tracking &amp; driver behaviour module</li> <li>Speed restriction 70mph (Engine management enabled)</li> <li>Rear Hi-visibility warning decals (Chapter 8) as standard fitment</li> <li>Warning decals — Smoking, towing &amp; operating instructions</li> <li>Adjustable work lamps</li> </ul>	Vehicles Drivers daily check & defect reporting regime Service /Maintain to manufacturer's guidelines MOT testing schedule Tachograph testing schedule (Where fitted)  Ancillary equipment winches, lifts etc. Maintenance and safety inspection schedule applicable to all ancillary equipment Testing schedule for all ancillary equipment compliant with all current legislation  Serious incident investigation and reporting process
